## SECTION I Amendment of §170-7 of Chapter 170 of the Code of the Town of Rockland

§170-7 of Chapter 170 of the Code of the Town of Rockland, entitled "Vehicles and Traffic," is hereby amended as follows:

- 1. A new paragraph B is hereby added to §170-7 to read as follows:
  - "B. Main Street and Pleasant Street in Livingston Manor.
    - (1) Parking is prohibited at any time on the southeasterly side of Main Street in either direction for a distance of 130 feet measured from the intersection of Main Street and Pleasant Street.
    - (2) Parking is prohibited at any time on northeasterly side of Pleasant Street along the lot identified as 67 Main Street."
- 2. Existing paragraph B of §170-7, entitled penalties, is hereby redesignated as paragraph C.

### SECTION II Effect of Invalidity

If any clause, sentence, phrase, paragraph or any part of this local law shall for any reason be adjudged finally by a Court of competent jurisdiction to be invalid, such judgment shall not effect, impair or invalidate the remainder of this local law, but shall be confined in its operation and effect to the clause, sentence, phrase, paragraph or any part thereof, directly involved in the controversy or action in which such judgment shall have been rendered. It is hereby stated to be the legislative intent that the remainder of this local law would have been adopted had any such provisions not been included.

### SECTION III Effective Date

This local law shall take effect immediately upon filing in the office of the Secretary of State.
