

**CITY OF ROCKWOOD**

**ORDINANCE NO. 484**

**AN ORDINANCE TO AMEND CHAPTER 248, ARTICLE I, SECTION 248-7(A) OF THE ROCKWOOD CITY CODE TO PROHIBIT PARKING ON THE WEST SIDE OF HAZEL STREET FROM HURON RIVER DRIVE TO 350 FEET NORTH OF HURON RIVER DRIVE.**

THE CITY OF ROCKWOOD ORDAINS:

**Section 1.** That Chapter 248, Article I, Section 248-7(A), of the Rockwood City Code is hereby amended to provide as follows:

Section 248-7. Prohibited parking places.

A. Generally. No person shall park any motor vehicle, at any time, at or on the following streets and locations, including any easements contiguous to such streets and locations, located within the city:

Burton Street	West	From Church Street to Huron River Drive
Cleveland Street	East	From Huron River Drive north to the northerly City limit of Cleveland Street
Fort Street	Both	From the southern City limits to Huron River Drive
German Street	Both	From Church to Fort Street
Hazel	West	From Lafler to Lynne
Hazel	Both	From Huron River Drive North 350 feet
Harding Street	North	From Burton to Lamont
Huron River Drive	Both	From Olmstead Road to Burton Street
Lamont Street	East	From Pingree to Huron River Drive
Mather Street	South	From York to Wood Street
Olmstead Road	Both	From Huron River Drive to East Ditner
Olmstead Road	West	From Huron River Drive to Woodruff Road
Pingree Street	North	From Fort Street 150 feet east to the alley
Swallow Drive	East	From the Huron River north 800 feet
Swallow Drive	East	From Huron River Drive south 300 feet
Swallow Drive	West	From Huron River Drive south to end of Swallow Drive
Truman Road	East	From Huron River Drive north to the northerly City limit of Truman Road
York Street	East	From Mather north to the dead end of York Street

**Section 2.** That all other provisions of Chapter 248, including Sections 248-7(B) and 248-7(C), of the Rockwood City Code shall remain in full force and effect.

**Section 3. Severability.** The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.

**Section 4. Repeal.** All other Ordinances inconsistent with the provisions of this Ordinance are, to the extent of such inconsistencies, hereby repealed.

**Section 5. Publication.** The City Clerk shall cause this Ordinance to be published in the manner required by law.

**Section 6. Effective Date.** This Ordinance shall become effective upon publication.


