

**ORDINANCE NO. 2519**  
**ROSS TOWNSHIP**  
**ALLEGHENY COUNTY, PENNSYLVANIA**

**AN ORDINANCE OF THE TOWNSHIP OF ROSS, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 15 OF THE ROSS TOWNSHIP CODE OF ORDINANCES, MOTOR VEHICLES AND TRAFFIC, § 413, NO STOPPING, STANDING, OR PARKING, TO PROHIBIT PARKING ONLY ON EVERY FRIDAY BETWEEN THE HOURS OF 6 AM AND 12 PM, WEST OF 155 AND 158 ON EILEEN DRIVE, ROSS TOWNSHIP, PITTSBURGH, PA 15237.**

**WHEREAS**, The Ross Township Board of Commissioners, Allegheny County, Pennsylvania, has the authority to adopt regulations restricting and regulating parking on streets located within Township limits pursuant to 75 Pa. C.S.A. § 3354(d)(2); and

**WHEREAS**, pursuant to section 1502.44 of the Pennsylvania First Class Township Code, 53 P.S. § 56544, the Board of Commissioners has the authority to enact and amend provisions of the Code of Ordinances of Ross Township (hereinafter the "Code") at any time it deems necessary for the health, safety, morals, cleanliness, beauty, convenience, comfort and general welfare of the Township and the inhabitants thereof; and

**WHEREAS**, the Board of Commissioners of the Township deems it necessary to amend the Code to promote and protect the health, safety and welfare of the residents of Ross Township, and on the recommendation of the Ross Township Police Department, the Ross Township Board of Commissioners has determined it necessary to designate a no parking area located west of 155 and 158 Eileen Drive, Ross Township, Pittsburgh, PA 15237 on every Friday morning between the hours of 6 am and 12 pm to accommodate the operation of waste hauling vehicles.

**NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE BOARD OF COMMISSIONERS OF ROSS TOWNSHIP, ALLEGHENY COUNTY PENNSYLVANIA AND IT IS HEREBY ORDAINED AND ENACTED BY AND WITH THE SAME THAT:**

**SECTION 1:**

The aforementioned Title/Summary and Whereas clauses are incorporated by reference, the same as if fully set forth herein at length.

**SECTION 2:**

Chapter 15 of the Code, §413, No Stopping, Standing, or Parking, is hereby amended to state that parking shall be prohibited at all times in the following locations:

On Eileen Drive, Ross Township, Pittsburgh, PA 15237, west of 155 and 158 Eileen Drive, on every Friday morning between the hours of 6 am and 12 pm to accommodate the operation of waste hauling vehicles.

**SECTION 3:**

The erection and maintenance of all necessary signage is hereby authorized. Said signage shall be placed so as to properly notify all vehicular traffic of the imposed regulations. Said signage shall comply with applicable state and federal laws, guidelines, standards and regulations.

**SECTION 4:**

The appropriate Officers of Ross Township are hereby authorized and directed to execute any and all documents necessary to effectuate the purposes of this Ordinance.

**SECTION 5:**

In the event that any section, sentence, clause, phrase or word of this ordinance shall be declared illegal, invalid, or unconstitutional by any Court of competent jurisdiction, such declaration shall not prevent or otherwise foreclose enforcement of any of the remaining provisions of this ordinance.

**SECTION 6:**

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, each such inconsistency or conflict is hereby specifically repealed.
