

**ORDINANCE NO. 2525**  
**ROSS TOWNSHIP**  
**ALLEGHENY COUNTY, PENNSYLVANIA**

---

**AN ORDINANCE OF THE TOWNSHIP OF ROSS, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 15, PARK 2, SECTION 214 (“STOP INTERSECTIONS ESTABLISHED”) OF THE ROSS TOWNSHIP CODE OF ORDINANCES, TO REGULATE AND RESTRICT THE MOVEMENT OF VEHICULAR TRAFFIC TRAVELING SOUTHWEST ON AN UNNAMED ROADWAY CONNECTING PENN DRIVE AND YORK DRIVE.**

**WHEREAS**, The Ross Township Board of Commissioners, Allegheny County, Pennsylvania, has the authority to adopt regulations restricting and regulating stopping, standing or parking on streets located within Township limits pursuant to 75 Pa. C.S.A. § 6109(a)(1); and

**WHEREAS**, pursuant to section 1502.44 of the Pennsylvania First Class Township Code, 53 P.S. § 56544, the Board of Commissioners has the authority to enact and amend provisions of the Code of Ordinances of Ross Township (hereinafter the “Code”) at any time it deems necessary for the health, safety, morals, cleanliness, beauty, convenience, comfort and general welfare of the Township and the inhabitants thereof; and

**WHEREAS**, the Board of Commissioners of the Township deems it necessary to amend the Code to promote and protect the health, safety and welfare of the residents of Ross Township, and on the recommendation of the Ross Township Police Department, the Ross Township Board of Commissioners has determined it necessary to install a stop sign on an unnamed roadway traveling Southwest where Penn Drive connects with York Drive.

**NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE BOARD OF COMMISSIONERS OF ROSS TOWNSHIP, ALLEGHENY COUNTY PENNSYLVANIA AND IT IS HEREBY ORDAINED AND ENACTED BY AND WITH THE SAME THAT:**

**SECTION 1:**

The aforementioned Title/Summary and Whereas clauses are incorporated by reference, the same as if fully set forth herein at length.

**SECTION 2:**

Chapter 15 of the Code, §15-214, Stop Intersections Established, is hereby amended to add a stop sign on an unnamed roadway traveling Southwest where Penn Drive connects with York Drive.

**SECTION 3:**

The erection and maintenance of all necessary signage is hereby authorized. Said signage shall comply with applicable state and federal laws, guidelines, standards and regulations.

**SECTION 4:**

The appropriate Officers of Ross Township are hereby authorized and directed to take such actions and execute any and all documents necessary to effectuate the purposes of this Ordinance.

**SECTION 5:**

In the event that any section, sentence, clause, phrase or word of this ordinance shall be declared illegal, invalid, or unconstitutional by any Court of competent jurisdiction, such declaration shall not prevent or otherwise foreclose enforcement of any of the remaining provisions of this ordinance.

**SECTION 6:**

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, each such inconsistency or conflict is hereby specifically repealed.
