## VILLAGE OF ROTHSCHILD MARATHON COUNTY, WISCONSIN AN ORDINANCE AMENDING THE CODE OF THE VILLAGE OF ROTHSCHILD PART III ZONING LEGISLATION, CHAPTER 590 ZONING, AMENDING SECTION 590-96.1 ENTITLED "ACCESSORY STRUCTURES."

The Village Board of the Village of Rothschild, Marathon County, Wisconsin, do ordain as follows:

Section 1: PART III ZONING LEGISLATION, CHAPTER 590 ZONING, SECTION 590-96.1 ENTITLED "ACCESSORY STRUCTRES." of the Code of the Village of Rothschild is hereby amended with new language <u>underlined</u> and deleted language <u>stricken</u> to provide as follows:

F. Metal buildings shall be limited to the commercial and industrial districts.
