BOROUGH OF ROSELAND COUNTY OF ESSEX, STATE OF NEW JERSEY

BOND ORDINANCE AMENDING SECTION 3(a) OF BOND ORDINANCE #25-2021 OF THE BOROUGH OF ROSELAND, IN THE COUNTY OF ESSEX, NEW JERSEY, FINALLY ADOPTED NOVEMBER 23, 2021, IN ORDER TO AMEND THE DESCRIPTION OF THE PROJECT.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF

ROSELAND, IN THE COUNTY OF ESSEX, NEW JERSEY (not less than two-thirds of all

members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(a) of Bond Ordinance #25-2021 of the Borough of Roseland,

in the County of Essex, New Jersey (the "Borough"), finally adopted November 23, 2021, is

hereby amended to include paving of municipal lots and to read as follows:

"(a) The improvement hereby authorized and the purpose for the financing of which the bonds are to be issued is various road improvements to Steel Court, Minnisink Drive, Lenape Drive, Stonegate Drive, Westview Avenue, Evergreen Place, Green Avenue and Glen Avenue, including, but not limited to, milling, resurfacing, drainage repairs, curb repairs, ADA compliant curb cuts, line striping, pavement markings and signage, and the paving of municipal parking lots and further including all work and materials necessary therefor and incidental thereto."

Section Two. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Three. This bond ordinance shall take effect 20 days after the first publication

thereof after final adoption, as provided by the Local Bond Law.
