**EFFECTIVE OCTOBER 17, 2022:** Part Time Non-Contractual employees shall be entitled to a minimum of two hours or actual time of training, whichever is more, for any mandatory training pursuant to the requirements of their position and the laws of the State of NJ, or as required by the Joint Insurance Fund which are scheduled by their supervisor outside of their regular shifts. All efforts shall be made by department supervisors to schedule training during regular shifts.

EFFECTIVE JANUARY 1, 2024: Statutorily required, pursuant to NJ Law, certified, exempt full-time employees shall be granted compensatory time upon written administrative approval for excessive overtime worked. However, banked compensatory time is subject to limits pursuant to N.J.A.C.4A:3-5.1, and is subject to the terms per FLSA, 29 CFR § 553.21-28.

All municipal employees are subject to administrative approval for overtime and compensatory time, whether by labor agreement, individual agreement, memo of understanding, and or written authorization prior to work performed.

**THEREFORE, BE IT RESOLVED**, that the salaries as specified shall be effective as of January 1, 2024 unless otherwise indicated.

**BE IT FURTHER RESOLVED**, all ordinances inconsistent with the provisions of this ordinance shall be and the same are hereby repealed but to the extent of such inconsistency only.
