

Recreation Committee Minutes August 30, 2017 5:15PM-7:08PM
Tour of Recreation Facilities, Update on Gymnasium, Park and Facility Fees proposal

The committee met at the Recreation Center on North St Ext. to give a tour of the facilities to anyone interested in vending or concession services for the City recreation department. Greg Foster of Pepsi was in attendance. Jerry Jokinen of Coca Cola has expressed interest in the concept but could not make it to the tour. Also, Mike Moore has expressed interest in selling some concessions out of a mobile unit. I will reach out to the 2 who were not able to make it for the tour. The group toured the Courcelle building and then went and looked at Giorgetti Park. Other possible sites for vending and or concessions would be Rotary Park, Monsignor Connor Park, and White Park. Other sites could have these services as well. The tour ended at 5:30 and the committee moved to City Hall for the rest of the agenda.

The update on the gymnasium was given to the committee. The gym would be built off the east end of the current building. The gym itself would be a full size gym with a lobby and rest rooms and storage attached. It would be a steel building. There would need to be some site work done like digging into the eastern hill and a retaining wall inserted, and some more parking added to the northeast part of the property. The estimated cost of the project is \$2.5 million. This has been a feasibility study. The building had already been prepped for an addition in that area prior to the City taking over the building. Infrastructure already exists in the general area.

The next portion of the meeting dealt with fees for exclusive use of City Parks and Facilities. Currently there are some fees charged at certain locations and not at others for use. Cindi is looking to have more consistency in the fee structure for use of the facilities and parks in the future. Cindi will be looking into and providing the Board with more numbers on what other municipalities charge for use of facilities. A preliminary fee sheet was provided at the meeting which is included in the minutes.

No action was taken on any of the topics discussed.
