LED LIGHTING

Bob Protovansky stated that the WWTP was converting to LED lighting and advised the Board that there was a retrofit kit available at \$64.00 with a energy rebate of \$60.00. Mr. Protovansky also noted that a local vendor was asked how much the kits would be if the city purchased 576 kits. Mr. Protovansky answered \$60.01, so the City could basically retrofit the WWTP for \$5.76. A motion was made to approve the request (Davis). **Motion passed.**

KOMATSU LOADER REPAIR

Project manager Sears was present to update the Board on a repair to the Komatsu Loader and briefed the Board on repair and associated \$7000.00 cost. The update was just for information, no action was requested.

The Board briefly spoke on locking up City Hall at 5 PM.
