A LOCAL LAW TO AMEND THE ZONING MAP IN THE UNIFIED DEVELOPMENT ORDINANCE TO REFLECT A CHANGE IN CLASSIFICATION FOR PARCELS 165.66-1-15, 165.66-1-17 AND 165.66-1-14 FROM A CLASSIFICATION AS "UR-3" (URBAN RESIDENTIAL-3) TO A CLASSIFICATION AS "AC" (ARTS AND CULTURE)

BE IT ENACTED, by the City Council of the City of Saratoga Springs, in consideration of changes in the Unified Development Ordinance (UDO) as follows:

SECTION 1. The Zoning Map in the Unified Development Ordinance is hereby amended to reflect a change in classification for parcels 165.66-1-15, 165.66-1-17 and 165.66-1-14 from a classification as "UR-3" (Urban nResidential-3) to a classification as "AC" (Arts and Culture).

SECTION 2. This Local Law shall take effect immediately upon filing in the office of the Secretary of the State of New York, in accordance with section 27 of the Municipal Home Rule Law.
