## LOCAL LAW 2024-3 AMENDING OFF-STREET PARKING AND LOADING REQUIREMENTS

BE IT ORDAINED AND ENACTED by the Town Board of the Town of Salina, County of Onondaga, State of New York, as follows:

Section 1. That Chapter 235 of the Town Code (Zoning) is hereby amended as follows:

§ 235-31. Off-street parking and loading requirements.

- A. General Regulations
- (4) Outdoor storage of vehicles
- (b) Recreation vehicles, including snowmobiles, motorcycles, boats and trailers and motor homes not in excess of 22 feet are allowed and may be parked or stored outdoors in any residential district, provided that no part or projection thereof is located within the front yard, except in established driveways and except if the recreational vehicle is 10' or more from the edge of the pavement from May 1 through November 1 of each year. All other types of vehicles are prohibited. Notwithstanding the foregoing, property owners within the Town of Salina may seek relief from this provision by virtue of obtaining a special permit subject to the requirements and provisions of Section 235-42 of this Code.

Section 2. This local law shall take upon the filing with the Secretary of State.


