

SAHUARITA ORDINANCE NO. 2026-201

AN ORDINANCE OF THE TOWN OF SAHUARITA, ARIZONA, AMENDING TITLE 3 REVENUE AND FINANCE, CHAPTER 3.10 FEE SCHEDULE, SECTION 3.10.150 PARKS AND RECREATION FEES, BY AMENDING SUBSECTION B FACILITY RENTAL FEES, SUBPARAGRAPH 11 SPORTS FIELD RENTAL FEES – PER FIELD; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Town of Sahuarita, Arizona, as follows:

Section 1. The Town of Sahuarita Municipal Code Title 3 Revenue and Finance, Chapter 3.10 Fee Schedule, Section 3.10.150 Parks and Recreation Fees is hereby amended by amending subsection B Facility Rental Fees, subparagraph 11 Sports Field Rental Fees – Per Field to read as follows:

- Section 2.** The various Town officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance and sections of the Town Code.
- Section 3.** All ordinances, resolutions, or motions and parts of ordinances, resolutions, or motions of the Town Council in conflict with the provisions of this ordinance are hereby repealed, effective as of the date of this ordinance. All internal references within the Town Code to any affected provision are hereby updated.
- Section 4.** If any section, subsection, sentence, clause, phrase or portion of this ordinance, or any part of this amendment to the Town Code, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
- Section 5.** The Town Clerk is hereby directed to publish this ordinance upon adoption as required by A.R.S. §§ 9-812 and 9-813.
- Section 6.** The effective date of this Ordinance is January 1, 2027.
