ORDINANCE OF THE COUNCIL OF THE CITY OF SANTA ROSA AMENDING
ORDINANCE 1544 TO CONVERT RILEY STREET BETWEEN FIFTH STREET AND
SEVENTH STREET FROM A ONE-WAY STREET TO A TWO-WAY STREET

THE PEOPLE OF THE CITY OF SANTA ROSA DO ENACT AS FOLLOWS:

Section 1. Section 2 of Ordinance Number 1544 of the City of Santa Rosa is amended as follows:

The following one-way streets are hereby established in the City of Santa Rosa:

1. Morgan Street between Third Street and Ninth Street – northbound
2. Davis Street between Seventh Street and Third Street - southbound
3. Healdsburg Avenue between College Avenue and Tenth Street - southbound
4. B Street between Tenth Street and Healdsburg Avenue - southbound
5. Maple Avenue between Brigham Avenue and Santa Rosa Avenue - westbound
6. Bennett Valley Road between Santa Rosa Avenue and Gordon Lane – eastbound
7. Osage Avenue between Del Rosa Avenue and Alta Vista Avenue- northbound
8. Sunrise Avenue between Alta Vista Avenue and Del Rosa Avenue – southbound
9. Ross Street between Mendocino Avenue and B Street – westbound

The following street is established as a two-way street in the City of Santa Rosa:

1. Riley Street between Fifth Street and Seventh Street

The establishment of Riley Street as a two-way street will be finalized when appropriate signing and striping has been modified to allow for two-way traffic.

Section 2. Environmental Determination. The Council finds that the adoption and implementation of this ordinance are exempt from the provisions of the California Environmental Quality Act as a Class 1 exemption in that the Council finds there is no possibility that the implementation of this ordinance may have significant effects on the environment.

Section 3. Severability. If any section, subsection, sentence, clause, phrase or word of this ordinance is for any reason held to be invalid and/or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance.

Section 4. Effective Date. This ordinance shall take effect on the 31st day following its adoption.

This ordinance was introduced by the Council of the City of Santa Rosa on April 9, 2024.


