ORDINANCE 2023-16

AN ORDINANCE AMENDING SECTION 2-25, FEES FOR SERVICES, AT SUBSECTION 2-25.5, "FEES FOR POLICE SERVICE," OF THE CODE OF THE TOWNSHIP OF SCOTCH PLAINS

BE IT ORDAINED, by the Mayor and Council of the Township of Scotch Plains, within the County of Union and State of New Jersey, as follows:

Section 1. Section 2-25, Fees for Services, at Subsection 2-25.5, "Fees of Escort Service" of the Code of the Township of Scotch Plains is hereby as follows:

Section 2-25.5 Fees for Police Services.

e. Rates for extra duty police assignments.

3. Rates. The Township Council of the Township of Scotch Plains ordains that in order to comply with the guidelines for extra duty police assignments, the following rate schedule will be in effect as follows:

Union County Vo-Tech Side Job Rate \$44.00 per hour

Security jobs \$650.00 per hour

Construction jobs \$70.00 per hour

Any hours beyond eight hours per day the rate of pay is one and one-half times the hourly rate set forth above. By way of example:

\$50.00 X 1.5 = \$75.00

\$70.00 x 1.5 = \$105.00

Construction related work has either four hours or eight hours minimum time.

Emergency Rate of \$90.00/hr for escort service not reserved within 24 hours.

~~\$100.00~~125.00 per day for police vehicle use for any extra duty assignment that requires same.

4. Administrative fee. In addition to the rates established in subparagraph 3, above, an administrative fee of 12.5% shall be added to the total fees charged for all Police Services provided for in this Section 2-25.5; **other than Religious, Board of Education or Shady Rest private events for which an administrative fee of 4.5% shall be added to the total fees charged for all Police Services provided for in Section 2-25.5.**
5. Designation of assignments. The Chief of Police is authorized to make assignments for extra duty work so that personnel are clearly under the direction and supervision of the Department.

Section 2. If any provision or portion of a provision of this ordinance is held to be unconstitutional, preempted by Federal or State law, or otherwise invalid by any court of competent jurisdiction, the remaining provisions of the ordinance shall not be invalidated. All ordinances or parts of ordinances, which are inconsistent with any provisions of this ordinance, are hereby repealed as to the extent of such inconsistencies.

Section 3. This ordinance shall take effect twenty days following adoption and publication in accordance with the laws of the State of New Jersey.
