

**TOWNSHIP OF SCOTCH PLAINS**

**ORDINANCE NO. 2023-12**

**AN ORDINANCE TO REPEAL SECTION 7-3.10 (PERMIT PARKING FOR RESIDENTS AND REPLACING WITH A NEW SECTION 7-3.10 (PERMIT PARKING) TO DESIGNATE PERMIT PARKING IN CHAPTER VII (TRAFFIC) OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF SCOTCH PLAINS.**

**BE IT ORDAINED** by the Township Council of the Township of Scotch Plains:

**SECTION 1.** Section 7-3.10 in Chapter VII (Traffic) of the Revised General Ordinances of the Township of Scotch Plains is hereby repealed and replaced as follows:

§ 7-3.10 **Permit Parking**

- a. The only parking permitted on those places listed in Schedule XXIV which can be found in Chapter **7A** shall be those persons displaying a valid and properly issued parking permit.
- b. The Mayor and Council designates the Township Manager as the individual who will set forth the parameters of the requirements for those persons who constitute and qualify as:
  1. Resident  
A resident must be a bonafide full-time resident and have proof thereof including but limited to a tax bill, driver's license or other documents; or as a
  2. Employee  
Any full-time, part-time, volunteer or contractor that is employed by the Township of Scotch Plains; or as a
  3. Visitor  
Any person that is conducting business with an employee of the Township of Scotch Plains.
- c. Parking permits shall be in the discretion of the Township Manager or his designee and that the number and nature of said permit shall be left to the discretion of the Township manager or his designee;
- d. This section shall be enforced by the Township police department and shall constitute the violation of this particular section and shall be in conformance with violations of N.J.S.A. 39:4-138.

**SECTION 2.** Schedule XXIV in Chapter VIIA (Traffic) of the Revised General Ordinances of the Township of Scotch Plains is hereby amended as follows:

**§ 7A-24 SCHEDULE XXIV: PERMIT PARKING.**

In accordance with the provisions of Subsection **7-3.10**, no person shall park a vehicle between the hours specified upon any of the following described streets or parts of streets unless displaying a duly authorized parking permit.

2435 Plainfield Avenue (Memorial Park)		6:00 AM – 3:00 PM Weekdays, excluding Federal Holidays	All parking spaces, excluding the handicap space

**SECTION 3.** All ordinances or parts of ordinances inconsistent herewith are hereby amended to the extent of such inconsistency.

**SECTION 4.** If any portion of this Ordinance shall be determined to be invalid, such determination shall not affect the validity of the remaining portions of said Ordinance.

**SECTION 5.** This Ordinance shall take effect upon final passage and publication in accordance with law, and upon posting of appropriate signs.

**SECTION 6.** The Chief of Police is hereby authorized and directed to arrange for the posting of appropriate signs.
