RESOLUTION NO. 35

AUTHORIZING THE MAYOR AND OTHER APPROPRIATE CITY OFFICIALS TO EXECUTE AND ENTER INTO A MUNICIPAL – MAIN STREET ORGANIZATION COOPERATION AGREEMENT BETWEEN THE CITY OF SCRANTON ("MUNICIPALITY") AND SCRANTON TOMORROW ("ORGANIZATION") IN ORDER TO RECEIVE FUNDS FROM THE COMMONWEALTH OF PENNSYLVANIA, DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT ("DCED") TO ASSIST WITH DOWNTOWN REVITALIZATION.

WHEREAS, by Resolution Number 105 of 2009, Scranton Tomorrow was designated as the City of Scranton's Main Street Program Manager for Downtown Revitalization, and under that designation Scranton Tomorrow will partner with the City of Scranton for the downtown and enable Scranton to realize the benefits of an active Main Street Program; and

WHEREAS, the City of Scranton desires to be a progressive leader in the effort to revitalize the Scranton Central Business District for both the economic welfare and general enjoyment of its residents; and

WHEREAS, Scranton Tomorrow is the local Organization charged with planning for and implementing the day-to-day programs, projects and activities necessary to successfully maintain the revitalization effort for the Scranton Central Business District; and

WHEREAS, the City of Scranton and Scranton Tomorrow, in an effort to strengthen their working relationships of revitalizing the central business district, do hereby express their mutual interest in the effective expenditure of the funding resources available to the downtown revitalization effort as a result of the City of Scranton's acceptance into and participation in the Main Street Program.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SCRANTON that the Mayor and other appropriate City officials are hereby authorized to execute and enter into a Cooperation Agreement with Scranton Tomorrow, substantially in the form attached hereto and made a part hereof, pursuant to the terms and conditions set forth therein.

SECTION 1. If any section, clause, provision or portion of this Resolution shall be held invalid or unconstitutional by any Court of competent jurisdiction, such decisions shall not affect any other section, clause, provision or portion of this Resolution so long as it remains legally enforceable minus the invalid portion. The City reserves the right to amend this Resolution or any portion thereof from time to time as it shall deed advisable in the best interest of the promotion of the purposes and intent of this Resolution, and the effective administration thereof.

SECTION 2. This Resolution shall become effective immediately upon approval.
