RESOLUTION NO. 55

AUTHORIZING THE MAYOR, OFFICE OF ECONOMIC AND COMMUNITY DEVELOPMENT AND OTHER APPROPRIATE CITY OFFICIALS FOR THE CITY OF SCRANTON TO ENGAGE WITH CHRYSALIS RESEARCH AND CONSULTING, LLC TO PROVIDE CONSULTANT WORK AND ADMINSTRATE OUR HUD 5 YEAR CONSOLIDATED PLAN WITHIN THE CITY OF SCRANTON.

WHEREAS, the Office of Economic and Community Development of the City of Scranton publicly sought requests for proposals to provide oversight and administration of the City of Scranton's HUD 5 Year Consolidated Plan.

WHEREAS, the most qualified proposal received to provide the requested administration, was submitted by CHRYSALIS RESEARCH AND CONSULTING, LLC. ("Chrysalis"). A copy of the Chrysalis Proposal is attached hereto as Exhibit "A"; and

WHEREAS, the City of Scranton desires to accept the proposal of Chrysalis by having Chrysalis oversee and administrate the City of Scranton's HUD 5 Year Consolidated Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SCRANTON that the Mayor, the Office of Economic and Community Development and other appropriate City Officials are hereby authorized to engage with Chrysalis Research and Consulting, LLC, to oversee and administrate the City of Scranton's HUD 5 Year Consolidated Plan and enter into any and all agreements related thereto.

SECTION 1. If any section, clause, provision or portion of this Resolution shall be held invalid or unconstitutional by any Court of competent jurisdiction, such decision shall not affect any other section, clause, provision or portion of this Resolution so long as it remains legally enforceable minus the invalid portion. The City reserves the right to amend this Resolution or any portion thereof from time to time as it shall deem advisable in the best interests of the promotion of the purposes and intent of this Resolution and the effective administration thereof.

SECTION 2. This Resolution shall become effective immediately upon approval.

SECTION 3. This Resolution is enacted by the Council of the City of Scranton under the authority of the Act of Legislature, April 13, 1972, Act No. 62, Known as the "Home Rule Charter and Optional Plans Law", and any other applicable law arising under the laws of the State of Pennsylvania.
