AN ORDINANCE

RATIFYING AND APPROVING AN INTERGOVERNMENTAL AGREEMENT OF COOPERATION AND MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF SCRANTON AND BOROUGH OF MOOSIC REGARDING COORDINATION ON ZONING, PLANNING, AND CODE ENFORCEMENT OF 53 GLENMAURA NATIONAL BOULEVARD.

WHEREAS, on or about November 17, 2000, the parties to this Agreement entered into an Intergovernmental Agreement regarding Pizzagalli L.L.C.'s purchase and development of land situate at 53 Glemmaura National Boulevard, Scranton, PA.; and

WHEREAS, on or about December 12, 2022, Commonwealth Charter Academy ("CCA") purchased property located at 53 Glenmaura National Boulevard, Scranton, Lackawanna, including but not limited to the building and its parking lot; and

WHEREAS, on or about May 8, 2024, the parties met with CCA to discuss their plans to renovate the land situated on the Property. CCA will deliver live and remote instruction to students from the Building and will outfit the building for the same. CCA also intends to update the Parking Lot for more parking spaces that are compliant with ADA Accessibility Standards; and

WHEREAS, Moosic and Scranton continue to maintain concurrent municipal jurisdiction with respect to the approval and inspection of the plans, specifications, and building(s) for the Property to ensure compliance with applicable building codes, zoning ordinances, and stormwater requirements within the parties' respective municipalities; and

WHEREAS, the City and Moosic desire to outline updated obligations and responsibilities as to the zoning, planning, and code enforcement of 53 Glenmaura National Boulevard, Scranton, Lackawanna, as outlined and incorporated hereto as Exhibit A.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SCRANTON that the Intergovernmental Agreement of Cooperation and Memorandum of Understanding on 53 Glenmaura National Boulevard Between the Borough of Moosic and The City of Scranton, attached hereto as Exhibit "A" and incorporated herein by reference thereto, is hereby ratified and approved.
