AN ORDINANCE

AMENDING FILE OF THE COUNCIL NO. 98, 2023, AN ORDINANCE, AS AMENDED, ENTITLED "APPROPRIATING FUNDS FOR THE EXPENSES OF THE CITY GOVERNMENT FOR THE PERIOD COMMENCING ON THE FIRST DAY OF JANUARY, 2024 TO AND INCLUDING DECEMBER 31, 2024 BY THE ADOPTION OF THE GENERAL CITY OPERATING BUDGET FOR THE YEAR 2024," (2024 OPERATING BUDGET) SO AS TO TRANSFER AN AMOUNT NOT TO EXCEED ONE HUNDRED THIRTY TWO THOUSAND DOLLARS (\$132,000.00) FROM THE BUREAU OF ADMINISTRATION CONTINGENCY ACCT NO. 100-45000-000-910-000000 TO FUND CLERICAL UNION RAISES THAT WERE NOT IDENTIFIED IN THE 2024 OPERATING BUDGET.

WHEREAS, the Clerical Union negotiated raises for the City of Scranton union employees; and

WHEREAS, the newly adopted Collective Bargaining Agreement requires the City to issue a raise to each member of the Clerical Union in the amount of two thousand dollars (\$2,000) for calendar year 2024; and

WHEREAS, because these raises were negotiated after adoption of the City's 2024 General Operating Budget, the City requires a transfer of funds budgeted in Contingency to provide for these raises; and

WHEREAS, §909 of the City's Home Rule Charter and §6-13 (B)(1) of the City's Administrative Code authorizes amendments to an adopted City operating budget upon the express approval of City Council.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SCRANTON that File of the Council No. 98, 2023, as amended, be further amended by transferring funds as follows:

The purpose of this transfer is to provide a salary for Clerical Union employee raises to comply with the Clerical Union Contract which was not identified in the 2024 Operating Budget.

SECTION 1. If any section, clause, provision or portion of this Ordinance shall be held invalid or unconstitutional by any Court of competent jurisdiction such decision shall not affect any other section, clause, provision or portion of this Ordinance so long as it remains legally enforceable minus the invalid portion. The City reserves the right to amend this Ordinance or any portion thereof from time to time as it shall deem advisable in the best interest of the promotion of the purposes and intent of this Ordinance, and the effective administration thereof.

SECTION 2. This Ordinance shall become effective immediately upon approval.

SECTION 3. This Ordinance is enacted by the Council of the City of Scranton under the authority of the Act of Legislature, April 13, 1972, Act No. 62, known as the "Home Rule Charter and Option Plans Law" and any other applicable law arising under the laws of the State of Pennsylvania.
