AN ORDINANCE OF SCOTT CITY, MISSOURI TO AMEND SUBSECTION 250.035 B IN TITLE II: PUBLIC HEALTH, SAFETY AND WELFARE, CHAPTER 250: SOLID WASTE RELATING TO BULKY RUBBISH COLLECTION; ESTABLISHING THE EFFECTIVE DATE; AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL

OF SCOTT CITY, MISSOURI, AS FOLLOWS:

SECTION ONE. Subsection B of Section 250.035 entitled Bulky Rubbish Collection in

Title II: Public Health, Safety and Welfare, Chapter 250: Solid Waste is hereby repealed and a

new Subsection 250.035 B is enacted in lieu thereof to read as follows:

"Section 250.035 Bulky Rubbish Collection.

BILL NO. 1325

B. Collection of Bulky Rubbish.

1. Collection of white goods and dwelling unit furniture.

a. The City's Public Works Director shall provide for the collection of white goods and dwelling unit furniture as defined above. White goods and bulky unit furniture shall be delivered by City residents to a City-designated site upon application and payment of the service fee. The City may also proclaim certain days to be set as white goods and dwelling unit furniture months each year. The Council may also set a service charge for said bulky items during these days at its discretion if they choose a service charge to be different than set out hereafter.

b. Unless otherwise designated, white goods and dwelling unit furniture shall be delivered by City residents to <u>1011 Rose Con Rd.</u>, <u>Scott City</u>, from <u>8:00 a.m.</u> until <u>3:00 p.m. on a City-designated date in March and in October of each year. a Citydesignated site twice a year from <u>8:00 a.m.</u> on Friday until <u>3:30 p.m.</u> on Friday and from <u>8:00 a.m.</u> on Saturday until <u>12:00 p.m.</u> on Saturday with spring collection to begin the first Friday prior to the commencement of daylight savings time and fall collection commencing the first Friday after daylight savings time ends.</u>

c. No bulky rubbish shall be place curb side, unless said rubbish came from the dwelling unit immediately adjoin the curb. Any person who places his/her bulky

rubbish along the curb of premises, other than his/her own, shall be guilty of littering under Chapter 155 of the City Code.

d. The Public Works Department shall not pick up any bulky rubbish item placed curb side, unless the resident has complied with all requirements of this Section.

e. The Public Works Department shall not accept any tree trunks, branches or limbs delivered by commercial tree service or an agent or stray party for a commercial tree service.

2. Collection of tree limbs or bundles of branches.

<u>a.</u> Tree limbs and bundles of branches may be delivered by City residents to the Public Works Department during normal business hours, provided the City resident has obtained the necessary permit as hereinafter set forth.

b. <u>The Public Works Department shall not accept any tree trunks, branches</u> or limbs delivered by commercial tree service or an agent or straw party for a commercial tree service.

3. Collection of bulky rubbish caused by storm damage. Following a storm which causes tree damage along alley or street easements, the City shall provide assistance in the removal of damaged trees and limbs. However, any resident requesting the City's assistance shall notify the City's Public Works Director of the damage within two (2) weeks after the storm. All tree limbs and branches shall be cut by the resident to manageable lengths of six (6) feet or less.

The remaining subsections of Section 250.035 remain unchanged, in full force and effect.

SECTION TWO. It is the intent of the Mayor and City Council of Scott City, Missouri, and it is hereby ordained that this ordinance shall become and be made a part of the Code of Ordinances of Scott City, Missouri, and that sections of this ordinance may be renumbered to accomplish such intention.

SECTION THREE. If any section, subsection, sentence, clause, phrase or portion of this ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.

SECTION FOUR. That this ordinance shall take effect and be in force from and after its passage and approval.

SECTION FIVE. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Read first time this 16 day of October, 2023.

Read second time this <u>16</u> day of <u>October</u>, 2023.
