

ORDINANCE 2024-08

AN ORDINANCE OF THE BOROUGH OF SEASIDE PARK, COUNTY OF OCEAN AND STATE OF NEW JERSEY AMENDING CHAPTER 435 ENTITLED "VEHICLES AND TRAFFIC", PART IV, ARTICLE XI, SECTION 435-44 OF THE CODE OF THE BOROUGH OF SEASIDE PARK, "CHARGES AND FEES"

WHEREAS, pursuant to N.J.S.A. 40:48-1 et seq., the governing body of every municipality may make, amend, repeal and enforce such ordinances, regulations, rules and by-laws not contrary to the laws of this state or the United States, as it may deem necessary and proper for the good government, order and protections of persons and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants, and as may be necessary to carry into effect the powers and duties conferred and imposed by law; and

WHEREAS, the Borough of Seaside Park is a body politic and corporate in law pursuant to N.J.S.A. 40A:60-1 et seq.; and

NOW THEREFORE, BE IT ORDAINED by the Governing Body of the Borough of Seaside Park, County of Ocean, State of New Jersey:

SECTION I.

- A. The Borough Code of Seaside Park, Chapter 435 is hereby amended and supplemented under § 435-44, which is entitled "Charges and fees," so as to increase the parking hourly rate, Monday through Friday, from one (\$1) dollar to two (\$2) dollars, and to increase the weekend and holiday parking hourly rate from two (\$2) dollars to three (\$3) dollars, and shall be read as follows:

§ 435-44 Charges and fees.

The owner or operator of a vehicle shall, immediately upon entering a designated paid parking space on any municipally owned street or in municipal parking lots 1, 2, and 3, pay the following:

- A. **The sum of \$2 for a period of one hour beginning 7:00 a.m. on Mondays through 7:00 p.m. on Fridays, excluding holidays, shall be in effect.**
- B. **The sum of \$3 for a period of one hour beginning 7:00 p.m. on Fridays through 7:00 a.m. on Mondays shall be in effect.**
- C. **On any holiday, the sum of \$3 for a period of one hour from 12:00 midnight at the beginning of the holiday through the next twenty-four-hour period shall be in effect.**

SECTION II.


All ordinances or parts thereof, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of their inconsistencies.

SECTION III.

In the event any section, part or provision of this Ordinance shall be held unconstitutional or invalid by any Court, such holding shall not affect the validity of this Ordinance or any remaining part of this Ordinance other than the part held unconstitutional or invalid.

SECTION IV.


This Ordinance shall take effect immediately upon its final passage and publication as required by law.
