

ORDINANCE 2026-20

AN ORDINANCE OF THE BOROUGH OF SEASIDE PARK, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING THE BOROUGH CODE OF THE BOROUGH OF SEASIDE PARK, SO AS TO AMEND CHAPTER 135, ENTITLED "BEACHES"

WHEREAS, pursuant to N.J.S.A. 40:48-1 et seq., the governing body of every municipality may make, amend, repeal and enforce such ordinances, regulations, rules and by-laws not contrary to the laws of this state or the United States, as it may deem necessary and proper for the good government, order and protections of persons and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants, and as may be necessary to carry into effect the powers and duties conferred and imposed by law; and

WHEREAS, the Borough of Seaside Park is a body politic and corporate in law pursuant to N.J.S.A. 40A:60-1 et seq.

BE IT ORDAINED, by the Governing Body of the Borough of Seaside Park, in the County of Ocean, State of New Jersey, as follows:

SECTION 1. The Borough Code of the Borough of Seaside Park is hereby amended and supplemented so as to amend Chapter 135, §135-7 entitled "Permits required for use of beach; rates" to delete §135-7B and §135-7C:

Deleted:

§135-7B

B. A \$275 seasonal parking permit may be purchased and enable the holder to park anywhere that parking spaces are metered 24 hours a day, seven days a week, except during restricted hours of the parking lots. The sticker will be affixed in the rear left corner window; and shall be assigned to one vehicle, first come first-served.

§135-7C

C. Daily permits: \$10 per person for a daily permit on weekdays and \$10 per person for a daily permit on holidays and weekends.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. The ordinance shall take effect after second reading and publication as required by law.
