ORDINANCE NO. 860

AN ORDINANCE OF SELINSGROVE BOROUGH, SNYDER COUNTY, PENNSYLVANIA, AMENDING SECTION 18-301, QUARTERLY CHARGE FOR SEWER SERVICE, OF CHAPTER 18, SEWERS AND SEWAGE DISPOSAL, OF THE SELINSGROVE BOROUGH CODE, THEREBY INCREASING SUCH CHARGES, AND PROVIDING FOR AN EFFECTIVE DATE.

The Council of the Borough of Selinsgrove, Snyder County, Pennsylvania, duly enacts the following Ordinance.

Section One. Authority. The authority for the enact of this Ordinance is set forth in Sections 1201 and 1202 of the Pennsylvania Borough Code, as amended (53 Pa.C.S. § 46101 and 46102 as amended).

Section Two. Purpose. This Ordinance is being enacted to promote the general health, welfare, and safety of the community by amending the sewer rates for all customers of its public sewer systems to thereby increase the same for 2022 and all years thereafter.

Section Three. Amendment Of Section 18-301, Quarterly Charge For Services, C.

Section 18-301, Quarterly Charge For Service, of Chapter 18, Sewers and Sewage Disposal, Part 3, Sewer Rates, Subsection C., shall hence forth read:

C. The rate schedule is as follows:

Number of Gallons	Rate	Rate Includes User Charge	Rate Includes Other Charge	
First 3,000	\$33.00	\$8.20	\$24.80	
Each 1,000 or part thereof thereafter	\$11.00	\$2.90	\$8.10	

The term "user charge" is a Pennsylvania Environmental Protection ("DEP") term meaning operating costs of the Selinsgrove Municipal Authority and the Borough. Each rate category include not less than the user charges as defined by the DEP.

The Sewer Rates set forth in this subsection C. shall henceforth be subject from time to time to change by a duly adopted resolution of the Borough Council of Selinsgrove Borough by way of a properly made, seconded, and carried motion of a majority of the councilpersons present at a duly advertised public or special meeting of said Council, which resolution shall be incorporated herein by this reference and shall have the same authority and effectiveness as if set forth herein at length.

The rest and remainder of Chapter 18, Sewers and Sewage Disposal, of the Selinsgrove Borough Code are unchanged by this amendment and are hereby confirmed and ratified hereby.

Section Four. Repealer. Any and all Ordinance, or parts of any Ordinance, contrary to the provisions of this Ordinance are hereby repealed.

Section Five. Severability. In the event a term, sentence, or provision of this Ordinance is deemed to be illegal or void then only such term, sentence or provision shall be stricken herefrom and the rest and remainder of this Ordinance shall remain in full force and effect.

Section Six. Effective Date. This Ordinance shall take effect on April 1, 2022.

Upon motion duly made at a public meeting, properly seconded, and carried, this Ordinance No. 860 is enacted this marraw 21, 2022.
