AN ORDINANCE OF THE BOROUGH OF SELINSGROVE, SNYDER COUNTY, PENNSYLVANIA, AMENDING SECTION 15-402, PARKING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS, FOR A SPECIFIC PORTION OF THE NORTH SIDE OF LINDA LANE BETWEEN ITS EASTERN TERMINUS AND PENNSYLVANIA STATE ROUTE 522 AT ITS WESTERN TERMINUS, OF CHAPTER 15, MOTOR VEHICLES AND TRAFFIC, OF THE SELINSGROVE BOROUGH CODE, AND AUTHORIZING THE ERECTION OF TRAFFIC CONTROL DEVICES FOR THE SAME.

The Council of the Borough of Selinsgrove, Snyder County, Pennsylvania, duly enacts the following Ordinance.

Section One. Authority. The authority for the enact of this Ordinance is set forth in Sections 1201 and 1202 of the Pennsylvania Borough Code as amended (53 Pa.C.S. § 46101 and 46102 as amended) and the Pennsylvania Vehicle Code, as amended.

Section Two. Purpose. The Borough Council enacts this Ordinance to promote and protect the best interests, safety and welfare of the residents of the Borough by prohibiting parking of vehicles on the north side of Linda Lane from its eastern terminus to its western terminus at Pennsylvania State Route 522 and authorizing the erection of traffic control devices at such intersection.

Section Three. Definitions. The following definitions shall apply in the interpretation and enforcement of this Ordinance.

Borough - The Borough of Selinsgrove, Snyder County, Pennsylvania.

Borough Council - The Borough Council of the Borough of Selinsgrove, Snyder County, Pennsylvania.

Person - Any and all natural person, partnership, corporation or other entity.

Linda Lane - The portion of Linda Lane between its eastern terminus and its western terminus at Pennsylvania State Route 522.

Street, Lane Or Avenue - The entire width between the boundary lines of every way publicly maintained when any part thereof is open to the use of the public for purposes of vehicular travel.

Section Four. Amendments of Selinsgrove Borough Code Chapter 15, Motor Vehicles and Traffic.

A. Section 15-402, Parking Prohibited At All Times In Certain Locations, is hereby amended to include the following:

The rest and remainder of Section 15-402 remains unchanged hereby.

Section Five. Erection Of Traffic Control Devices. The Borough is hereby authorized to purchase and erect any and all traffic control devices that are necessary for the posting of the stop and parking prohibited requirements set forth in this Ordinance. In erecting such devices the Borough shall comply with the regulations promulgated by the Pennsylvania Department of Transportation.

Section Six. Violations And Penalties. Any violation or failure to comply with the provisions of this Ordinance shall constitute a summary offense and prosecution for every offense shall be according to the practices of summary convictions before the District Magistrate. Any violator, upon conviction, shall be sentenced to pay a fine of not less than Twenty-Five Dollars (\$25.00) nor more than Three Hundred Dollars (\$300.00) for each offense.

Section Seven. Repealer. Any and all Ordinance, or parts of any Ordinance, contrary to the provisions of this Ordinance are hereby repealed. The rest and remainder of Chapter 15, Motor Vehicles and Traffic, are hereby confirmed and ratified.

Section Eight. Severability. In the event a term, sentence, or provision of this Ordinance is deemed to be illegal or void then only such term, sentence or provision shall be stricken herefrom and the rest and remainder of this Ordinance shall remain in full force and effect.

Section Nine. Effective Date. This Ordinance shall take effect immediately upon its enactment.
