

## RESOLUTION NO. 2023-06

### SELINGROVE BOROUGH SNYDER COUNTY, PENNSYLVANIA

The council of the Borough of Selinsgrove, Snyder County, Pennsylvania, by motion duly made, seconded, and carried, adopts and enacts the following:

**WHEREAS**, on April 3, 2023, Councilperson, Christopher Kalcich, of the Selinsgrove Borough Council tendered his resignation from such Council (“Resignation”); and

**WHEREAS**, a quorum of the Selinsgrove Borough Council on motion duly made, seconded, and carried, accepted the Resignation at its regular meeting on April 3, 2023; and

**WHEREAS**, the terms of office for Christopher Kalcich expires on December 31, 2023, and

**WHEREAS**, the Selinsgrove Borough Council desires to fill the vacancy created by the Resignation and to that end has received the names of several registered electors who have continuously resided in the Borough of Selinsgrove for at least one (1) year prior to the date hereof; and

**NOW, THEREFORE**, intending for the foregoing paragraphs to be a part hereof, the Borough Council resolves as follows:

**RESOLVED**, that the Borough Council at the duly advertised public meeting reviewed and considered the following registered elector who has continuously resided within the Borough of Selinsgrove for a least one (1) year prior to the date hereof:

; and

**RESOLVED**, that upon a motion duly made, seconded, and carried, the Borough Council appoints Shane Hendricks to fill the term created by the resignation of Christopher Kalcich, which appointment shall expire on December 31, 2023; and



**RESOLVED, FINALLY**, this Resolution shall take effect immediately upon its adoption by the Borough Council.


