**RESOLUTION NO. 2024-07**

**A RESOLUTION OF THE BOROUGH OF SELINGSGROVE, SNYDER COUNTY, PENNSYLVANIA  
AUTHORIZING PENNDOT TO REQUEST RAILROAD CROSSING UPGRADES AT WATER STREET,  
STRAWBERRY ALLEY, WEST PINE STREET AND UNIVERSITY AVENUE**

**FROM THE PENNSYLVANIA PUBLIC UTILITY COMMISSION**

WHEREAS, Water Street, Strawberry Alley, West Pine Street and University Avenue are public roadways under the jurisdiction of Selinsgrove Borough; and

WHEREAS, a railway operates through Selinsgrove Borough, which railway maintains crossing over Water Street, Strawberry Alley, West Pine Street and University Avenue; and

WHEREAS, in order for the safety improvements to be made pertaining to the railway crossing, such improvements must be submitted to the Pennsylvania Public Utility Commission ("PUC") by and through the Pennsylvania Department of Transportation ("PennDOT");


NOW THEREFORE, IT IS HERBY RESOLVED BY SELINGSGROVE BOROUGH AS FOLLOWS:

1. PennDOT is authorized on behalf and for Selinsgrove Borough to request approval of the PUC to permit the installation of crossing upgrades, including, but not limited to appropriate warning devices, crossing surface replacements, and crossing closures at the railway crossings at Water Street, Strawberry Alley, West Pine Street and University Avenue (DOT #517 518P, 517 519W, 517 521X and 517 522 E 746A), at-grade, crossing in Selinsgrove Borough.
2. PennDOT is authorized on behalf and for Selinsgrove Borough to request approval of the PUC to issue Notice to Proceed letters to the railroad for construction at the railway crossings at Water Street, Strawberry Alley, West Pine Street and University Avenue in Selinsgrove Borough.


