ORDINANCE NO. 1697 (2023)

AN ORDINANCE TO AMEND THE REVISED GENERAL ORDINANCES OF THE CITY OF SEA ISLE CITY, CHAPTER 7 "TRAFFIC" TO PROHIBIT PARKING ON THE NORTH SIDE OF 43RD PLACE FROM PARK ROAD TO THE BAY AND TO ADJUST THE HOURS OF THE LOADING ZONE AT 43RD AND PARK

WHEREAS, the Council of the City of Sea Isle City from time to time reviews parking regulations and amends the same; and

WHEREAS, the City determines, under its general police powers, it is in the best interest of traffic flow and parking to prohibit parking on the north side of the 300 block of 42nd place from Park road to the bay; and

WHEREAS, the City provides for a loading and unloading area along 43rd street south side east of Park Road and seeks to change the loading and unloading times from 5:00 am to 7:00 am and 4:00 pm to 6:00 pm to 5:00 am to 5:00 pm during the months of May1 through October 1 of each year.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sea Isle City, County of Cape May and State of New Jersey as follows:

SECTION I. Chapter 7 Section 7.7 of the Revised General Ordinances of the City of Sea Isle City, entitled "Parking Prohibited at all Times on Certain Streets" "PART 1" only is hereby amended to delete the entire chart in its entirety and replace same as follows: **DELETED SECTION:**

SECTION III. Severability. If for any reason any section of this Ordinance shall be declared illegal by any Court of competent jurisdiction, the remaining section of the Ordinance shall remain in full force and effect, notwithstanding.

SECTION IV. Repealer. Any Ordinance or provision thereof inconsistent with this Ordinance is hereby repealed to the extent of such inconsistency.

SECTION V. Publication. This Ordinance shall take effect immediately upon the adoption and publication in accordance with the law.
