

# CITY OF SHAMOKIN

## ORDINANCE 21-03

BE IT ORDAINED AND ENACTED BY THE COUNCIL OF THE CITY OF SHAMOKIN, PA, AND IT IS HEREBY ORDAINED AND ENACTED BY THE AUTHORITY OF THE SAME, AN ORDINANCE TO BE KNOWN AS THE CURBSTONE MARKET ORDINANCE.

### **Article I Establishment and Operation**

#### ***§ 318-1 Establishment; days; hours; location.***

From and after the passage of this article, there is hereby established a curbstome market in the City of Shamokin, County of Northumberland and State of Pennsylvania, with the days to be set by resolution, the same to be held during the hours set by resolution by the City Council, until otherwise changed by the City Council.

The market shall be held on Independence Street along the south curb thereof from Orange Street to Market Street.

#### ***§ 318-2 Street and sidewalk use restrictions.***

The vehicles shall be so placed along the curb as not to interfere with public travel or with any street crossings and shall not be permitted to occupy the street in any other position than by being backed up against and at right angles to the curbstone or shall not occupy a larger space or position thereof than the width of such vehicle.

No person attending market will be permitted to occupy or use a bench, stand or otherwise more than three feet in width of the sidewalk measuring from the curbstone.

No person or persons shall be allowed to obstruct or pass up or down the market sidewalks or pavements with any cart or other conveyance with the object of selling therefrom during the market hours.

#### ***§ 318-3 Sale of live animals***

No person shall sell, or expose for sale, in said market any live animals.

#### ***§ 318-4 Street cleaning.***

It shall be the duty of the vendors to keep the streets clean of all rubbish, refuse or any dirt left on them after market.

#### ***§ 318-5 Delivery permits.***

No person or persons attending market, having their stock or any part thereof engaged or sold, shall be permitted to operate during market hours without first obtaining a permit from City Hall, and must adhere to all city policies concerning applicable peddler permits.

**§ 318-6 Violations and penalties.**

Any person, firm or corporation who shall violate or fail to comply with any of the provisions of this article shall, upon conviction thereof before any Magisterial District Judge, be sentenced to pay a fine of not less than \$100 and not more than \$300 and costs of prosecution and/or suffer imprisonment for up to 180 days, or both. The continuation of such violation for each successive day shall constitute a new and separate offense, and the person or persons allowing the continuation of the violation may be punished as provided above for each separate offense.

**§ 318-7 Repealer.**

All ordinances or parts of ordinances inconsistent herewith be and the same are hereby repealed.

**Article II Market Square**

**§ 318-8 Applications for spaces and stalls.**

From and after the passage of this article, all farmers, vendors and tradespeople attending the market commonly known as the "Curbstone Market," in the City of Shamokin, established by ordinance approved the 11th day of July 1917, being an ordinance establishing a curbstome market, shall have the right and privilege to obtain and secure a permanent stall or place to locate and station their respective cars, trucks, vehicles, counters and other necessary equipment by making the application, paying the fees and complying with the provisions of this article and the guidelines set forth by the Curbstone Market Committee, which are set by resolution, and subject to change as prescribed by City Council.

**§ 318-9 Rental fees.**

All parties leasing or renting one of said spaces or sections shall pay to the City, for the use of the same and for the supervision and reservation thereof, a rental or fee to be set by resolution, to be paid to at City Hall, yearly in advance.

**§ 318-10 Reservation of rented spaces.**

On all market days, City officials shall reserve all spaces and sections leased and rented and shall keep the same open and unoccupied for the lessee or party renting the same for the duration of the operating hours as set forth by resolution.

**§ 318-11 Compliance with curbstome market regulations.**

All parties attending the City of Shamokin Curbstone Market under and by virtue of the provisions of this article shall comply with all of the conditions, stipulations and provisions of Article I of this chapter.

**§ 318-12 Repealer.**

All ordinances or parts of ordinances inconsistent herewith be and the same are hereby repealed.


