ORDINANCE NO. 2022- OZAN ORDINANCE OF THE CITY OF SHAMOKIN, NORTHUMBERLAND COUNTY, PENNSYLVANIA, TO AMEND THE STREETS AND SIDEWALKS ORDINANCE, IN THE CITY OF SHAMOKIN

<u>SECTION 1.</u> The Council of the City of Shamokin, County of Northumberland and Commonwealth of Pennsylvania, under the authority of the Third Class City Code, hereby amends Ordinance No. 458, as follows:

SECTION 2. Chapter 458-14. Prohibited Obstructions; Violations and Penalties

ARTICLE I. Prohibited Obstructions; Violation and Penalties, shall be amended to read as follows:

SECTION 458-14.

- Α. The construction, maintenance or placing of any permanent or temporary structure, encroachment, advertising signs or obstruction upon or over any sidewalk of any public street in the City, other than those permitted by the Building Code and the Zoning Code, is prohibited; provided, however, that the owners or occupants of properties abutting a sidewalk may place temporary obstructions, such as tables and display racks, upon the sidewalk immediately abutting such property or upon the sidewalk abutting any other property with the permission of the owner or occupant thereof, so long as such obstruction or encroachment does not interfere with the rights of the public to traverse said sidewalk safely and conveniently but must leave at least forty-eight (48) inches for traverse. The owner or occupant of the property abutting the sidewalk may, upon obtaining a permit therefore from the Bureau of Codes Enforcement, place tables and chairs upon the sidewalk immediately abutting such property from which food and beverage may be dispensed, provided that the same shall not interfere with the rights of the public to traverse the sidewalk safely and conveniently. establishment operated with the permit must also be in full compliance with the statutes, ordinances and applicable regulations and furthermore does not grant any additional rights under any permits or licenses issued by the Commonwealth
- B. Every violation of this article shall be deemed a nuisance and every person so offending shall, upon conviction thereof, forfeit and pay for every such offense in sum not less than \$100.00 nor more than \$500.00, to be recovered in the name of the City of Shamokin as debts of the same amount are by law recoverable and paid into the treasury for the use of the City.

<u>SECTION 3.</u> All ordinances or parts thereof inconsistent with this amendment are hereby repealed.

SECTION 4. EFFECTIVE DATE:

This Ordinance shall be effective ten days after enactment.
