ORDINANCE NO 22-02

AN ORDINANCE OF THE CITY OF SHAMOKIN, NORTHUMBERLAND COUNTY,
PENNSYLVANIA AMENDING THE APPEARANCE TICKET ORDINANCE TO INCLUDE
UPDATED REFERENCES.

WHEREAS, the City of Shamokin wishes to update the standards adopted for property maintenance.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SHAMOKIN that:

SECTION 1. City Council authorizes the following language to be amended in Chapter 93 Section 3 of the City of Shamokin ordinances code.

Quality of Life Violations. Violations of the following Sections of the IPMC, and appropriate Shamokin ordinances, shall be deemed to be QUALITY OF LIFE VIOLATIONS as defined herein, to be enforced in the manner set forth in this ordinance

- A. The provisions of any article so enumerated shall be enforced by police officers, Code Enforcement Officers, or any public officer sworn to uphold and enforce the law of the municipality.
- B. The Shamokin City Council may from time to time change, increase or decrease those sections to be covered under this chapter by resolution passed at a regular monthly meeting. The following sections will be included on the ticket and have the associated references:

IPMC 302	Health Comfort Sanitary Conditions
IPMC 302.4	Brush, Grass and Weeds
IPMC 302.8	Vehicles, Junked and Abandoned
IPMC 308	Dumping and Littering (rubbish and garbage)
Sh 132	Animals
Sh 245	Outdoor Burning
Sh 450.16	Municipal Waste
Sh 458.25	Snow Removal

SECTION 2. City Council authorizes the following language to be amended in Chapter 93 Section 5 of the City of Shamokin ordinances code.

- A. For the first offense of a violation as set forth in this chapter within a twelve-month period, the tickets shall be issued in the amount of \$25.
- B. For the second offense of a violation as set forth in this chapter within a twelve-month period, the tickets shall be issued in the amount of \$75.
- C. For the third offense of a violation as set forth in this chapter within a twelve-month period, the tickets shall be issued in the amount of \$150.
- D. For the fourth offense and all subsequent offenses of a violation as set forth in this chapter within a twelve-month period, the ticket shall be issued in the amount of \$300.


SECTION 3. If any section, clause, provision or portion of this Ordinance shall be held invalid or unconstitutional by any Court of competent jurisdiction, such decision shall not affect any other section, clause, provisions or portion of this Ordinance so long as it remains legally enforceable minus the invalid portion. The City reserves the right to amend this Ordinance or any portion thereof from time to time as it shall deem advisable in the best interests of the promotion of the purposes and intent of this Ordinance and the effective administration thereof.

SECTION 4. All ordinances or parts thereof which may conflict with the provisions of this ordinances are hereby repealed.
