## ORDINANCE #23-966

## AN ORDINANCE OF THE BOROUGH OF SHIPPENSBURG, CUMBERLAND AND FRANKLIN COUNTIES, PENNSYLVANIA 2024 TAX LEVY – PROPERTY FRANKLIN COUNTY

AN ORDINANCE, of the Borough of Shippensburg, Cumberland and Franklin Counties, and the Commonwealth of Pennsylvania, fixing the tax rate for the year 2024.

BE IT ENACTED AND ORDAINED and it is hereby enacted and ordained by the Borough Council of the Borough of Shippensburg, Counties of Cumberland and Franklin, Pennsylvania:

**SECTION 1:** That a tax be and the same is hereby levied on all property within the said Borough, in the County of Franklin, subject to taxation for the fiscal year 2024, as follows:

- a. Tax rate for general purposes, the sum of 26.79 mills on each dollar of assessed valuation, or the sum of \$2.679 on each One Hundred Dollars (\$100.00) of assessed valuation.
- b. For street lighting purpose, the sum of 1.68 mills on each dollar of assessed value or the sum of \$.168 on each One Hundred Dollars (100.00) of assessed valuation.
- c. For fire protection purpose, the sum of 2.33 mills on each dollar of assessed valuation, or the sum of \$.233 cents on each One Hundred Dollars (100.00) of assessed valuation.
- d. For recreation purpose, the sum 1.80 mills on each dollar of assessed valuation, (changed from 1.59) or the sum of .180 cents on each One Hundred Dollars (100.00) of assessed valuation.
- e. Making a total tax for all Borough purposes of 32.60 mills. The same being summarized in tabular form as follows:

Tax Rate for General Purposes	26.79 Mills	\$2.679
Tax Rate for Street Lighting Purposes	1.68 Mills	\$ .168
Tax Rate for Fire Protection Purposes	2.33 Mills	\$ .233
Tax Rate for Recreation Purposes	1.80 Mills	\$.180

**SECTION 2:** That any ordinance, or part of ordinance, conflicting with this ordinance be and the same is hereby repealed insofar as the same affects this Ordinance.
