

ORDINANCE #23-965

**AN ORDINANCE OF THE BOROUGH OF SHIPPENSBURG,
CUMBERLAND AND FRANKLIN COUNTIES, PENNSYLVANIA
2024 TAX LEVY – PROPERTY
CUMBERLAND COUNTY**

AN ORDINANCE, of the Borough of Shippensburg, Cumberland and Franklin Counties, and the Commonwealth of Pennsylvania, fixing the tax rate for the year 2024.

BE IT ENACTED AND ORDAINED and it is hereby enacted and ordained by the Borough Council of the Borough of Shippensburg, Counties of Cumberland and Franklin, Pennsylvania:

SECTION 1: That a tax be and the same is hereby levied on all property within the said Borough, in the County of Cumberland, subject to taxation for the fiscal year 2024, as follows:


- a. Tax rate for general purposes, the sum of 2.583 mills on each dollar of assessed valuation, or the sum of \$.2583 on each One Hundred Dollars (\$100.00) of assessed valuation.
- b. For street lighting purpose, the sum of 0.161 mills on each dollar of assessed value or the sum of \$.0161 on each One Hundred Dollars (100.00) of assessed valuation.
- c. For fire protection purpose, the sum of 0.224 mills on each dollar of assessed valuation, or the sum of \$.0224 on each One Hundred Dollars (100.00) of assessed valuation.
- d. For recreation purpose, the sum of 0.25 mills on each dollar of assessed valuation, (changed from .221) or the sum of \$.025 on each One Hundred Dollars (100.00) of assessed valuation.
- e. Making a total tax for all Borough purposes of 3.218 mills. The same being summarized in tabular form as follows:

Tax Rate for General Purposes	2.583 Mills	\$.2583
Tax Rate for Street Lighting Purposes	0.161 Mills	\$.0161
Tax Rate for Fire Protection Purposes	0.224 Mills	\$.0224
Tax Rate for Recreation Purposes	<u>0.25 Mills</u>	<u>\$.0250</u>
TOTAL -	3.218 Mills	\$.3218


SECTION 2: That any ordinance, or part of ordinance, conflicting with this ordinance be and the same is hereby repealed insofar as the same affects this Ordinance.
