**AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE
AN AGREEMENT WITH GRANTWOOD VILLAGE, MISSOURI**

WHEREAS, the City of Shrewsbury, Missouri previously entered into an agreement with the town of Grantwood Village relating to municipal court payments; and

WHEREAS, the City wishes to enter into a new Agreement with Grantwood Village as set forth herein.


BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF SHREWSBURY AS FOLLOWS:

SECTION 1. The Mayor is hereby authorized to execute an agreement with the town of Grantwood Village, Missouri pertaining to the Grantwood Village Municipal Court.

SECTION 2. The Agreement is hereby attached in form as Exhibit A, subject to ministerial revisions by the City Attorney.

SECTION 3. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor and Board of Aldermen.

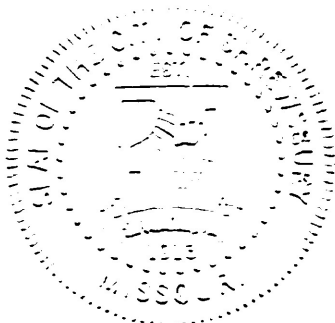

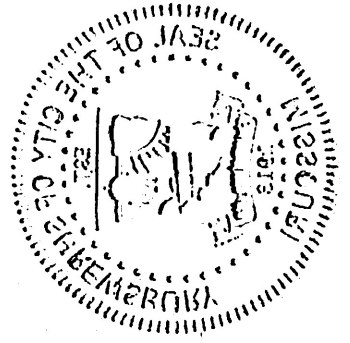

AGREEMENT

This Agreement made and entered into this 17 day of June, 2024, by and between the Town of Grantwood Village, Missouri, a Municipal Corporation, of the County of St. Louis, State of Missouri, herein referred to as Grantwood Village; and the City of Shrewsbury, Missouri, a Municipal Corporation, of the County of St. Louis, State of Missouri, herein referred to as Shrewsbury (collectively, the “Parties);

WHEREAS, Grantwood Village and Shrewsbury previously entered into an Agreement for Acceptance of In-Person Municipal Court Payments (the “Agreement”) that Shrewsbury accept payments (by cash, check or electric form) from defendants seeking to make In-Person payments relating to cases pending before Grantwood Village Municipal Courts; and

WHEREAS, Grantwood Village and Shrewsbury subsequently amended the Agreement to include specific language addressing Shrewsbury’s responsibility to respond to telephone inquiries regarding the Grantwood Village Municipal Courts; and

WHEREAS, the Parties now wish to amend, replace, and otherwise restate the Agreement to read as follows:

1. Only payments made In-Person during normal business hours at the Shrewsbury City Center will be accepted.
2. During normal business hours, the Court Administrator for the City of Shrewsbury shall reasonably answer and respond to telephone calls regarding the Grantwood Village Municipal Courts.
3. In consideration of Shrewsbury’s agreement to accept the payments and respond to the inquiries described herein, Grantwood Village will pay Shrewsbury the amount of \$100.00 on or before the first of each calendar month beginning June 1, 2024 and continuing thereafter.

4. Within thirty (30) days notice to the other party to this contract, either Grantwood Village or Shrewsbury may terminate this agreement for any reason in their sole discretion.
