Section 1. Section 400 7 of the Code of the Village Sleepy Hollow entitled " Parking restricted in designated locations " is amended as annexed hereto as same.

Section 2. Section 400 10 of the Code of the Village Sleepy Hollow entitled " Restrictions of west side parking on certain days " is amended annexed hereto as same.

Section 3. Section 400 11 of the Code of the Village Sleepy Hollow entitled " Restriction of east side parking on certain days. " is amended as annexed hereto as same.

Section 4. The invalidity of any word, section, clause, paragraph sentence, part, or provision of this local law shall not affect the validity of any part of this local law which can be given effect without such invalid part or parts.


