Liss Board Room, 99 West Main Street, Smithtown, New York on Tuesday April 2, 2024 at 2:00 p.m. time then in effect and duly adopted Local Law #10-2024, previously heard as Proposed Local Law #10-2024, amendments to Chapter 108 of the Town Code entitled, "Boat Basin and Mooring Areas," regarding permits, pursuant to Public Hearing held on April 2, 2024, SEQRA Type II Determination and the recommendation of the Town Attorney.

Local Law #10-2024 Chapter 108. Boat Basin and Mooring Areas

Chapter 108. Boat Basin and Mooring Areas §108-4. Permit requirements; additional requirements; application.

B. The Town Clerk shall compile a list of applications in order of filing, which shall be known as the "Permit Waitlist." A one-time fee of \$25 shall accompany each application to be added to the Permit Waitlist. ~~There shall also be a one-time \$25 Waitlist retention fee for all individuals currently on the Permit Waitlist who wish to retain their spots. Said fees shall be effective immediately.~~ Only two residents per household or taxpayers per parcel of property of at least sixteen years of age may hold a spot on the Permit Waitlist.

C. The Town Clerk ~~Board~~ shall have the power and authority to adopt and from time to time amend reasonable rules and regulations consistent with this chapter.

§108-5. Term of permit.

Upon the effective date of this section, newly issued permits to first-time permit holders shall be issued for a total period of fifteen (15) years.
