**ORDINANCE NO. 4 OF 2020**

**AN ORDINANCE OF THE TOWNSHIP OF SOUTH FAYETTE,  
ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING  
CHAPTER 227, VEHICLES AND TRAFFIC, ARTICLE III, STOP  
INTERSECTIONS, EXHIBIT “A” OF THE SOUTH FAYETTE  
CODE TO ESTABLISH STOP INTERSECTIONS AT THE  
INTERSECTION OF NEWBURY HIGHLAND AND GROMWELL  
LANE; NEWBURY HIGHLAND AND CELEBRATION CIRCLE,  
AND CELEBRATION CIRCLE AND GROMWELL LANE.**

WHEREAS, the Board of Commissioners of the Township of South Fayette has studied traffic conditions at or near the intersections of Newbury Highland and Gromwell Lane; Newbury Highland and Celebration Circle; Celebration Circle and Gromwell Lane; and

WHEREAS, the installation of stop signs, at such locations, are necessary and appropriate as a speed calming and safety device.

NOW, THEREFORE, BE IT ORDAINED AND IT IS HEREBY ORDAINED AND ENACTED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF SOUTH FAYETTE AS FOLLOWS:

1. Chapter 227, Vehicles and Traffic, Article III, Stop Intersections, Exhibit “A” of the South Fayette Code is hereby amended to permit the installation of stop signs, at the following locations:

Newbury Highland	South	Newbury Highland & Gromwell Lane
Newbury Highland	North	Newbury Highland & Gromwell Lane

<b><u>Stop Sign on</u></b>	<b><u>Direction of Travel</u></b>	<b><u>At Intersection of</u></b>
Gromwell Lane	East	Newbury Highland & Gromwell Lane
Gromwell Lane	West	Newbury Highland & Gromwell Lane
Newbury Highland	South	Newbury Highland & Celebration Circle
Celebration Circle	South	Celebration Circle & Gromwell Lane
Celebration Circle	North	Celebration Circle & Gromwell Lane
Celebration Circle	East	Celebration Circle & Newbury Highland
Gromwell Lane	West	Celebration Circle & Gromwell Lane

2. The proper officials of the Township of South Fayette are hereby authorized and directed to do all things necessary to effectuate the purpose of this ordinance.

3. All ordinances and parts of ordinances inconsistent with the terms of this ordinance are hereby repealed; provided, however, that such repeals shall be only to the extent of such inconsistency and in all other aspects, this ordinance shall be cumulative of the other ordinance regulating and governing the subject matter covered by this ordinance.

4. If any section or provision or parts hereof in this ordinance shall be adjudged invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the validity of the ordinance as a whole or any other section or provision or part thereof.

5. This ordinance shall be in full force and effect from and after its passage.
