1. Section 116-2 Scope; display of numbers required is amended by adding the following at the end thereof:

"Any road servicing three or more houses will be assigned a road name by the Town for easily identifiable vehicle access. In addition, in the event that more than one house has access from a single driveway, the number of the house must be displayed at each location at which the driveway diverges, and on the house."
