ORDINANCE 2024-25

AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 289 OF THE BOROUGH CODE, ENTITLED "STREETS AND SIDEWALKS"

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Borough of South River, County of Middlesex, State of New Jersey, as follows:

SECTION 1. Chapter 289 of the Borough Code of the Borough of South River, entitled Streets and Sidewalks is hereby amended as supplemented to add Article VI entitled "Personal Property In the Right of Way" code to read entirely as follows:

Article VI- Portable Basketball Hoops in the Right of Way

§289-27 Portable Basketball Hoops

- A. Portable Basketball Hoops shall not be placed, stored or utilized on any Borough Street.
- B. Portable Basketball Hoops shall not be placed within 50 feet of a street corner.
- Portable Basketball Hoops may be temporarily placed in the right of way between any sidewalk
 and street only while in use as long as the property is not blocking any sidewalk.
- D. A property owner shall be responsible for any damage to Borough equipment due to the placement of the portable basketball hoop in the right of way.

§ 289-28 Violation and Penalties

Any person who violates or who fails or refuses to comply with this article shall be liable to a penalty as prescribed in Chapter 1, § 1-1, General Penalty, of this Code, for each offense, to be recovered by and in the name of the municipality.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
