AN ORDINANCE OF THE BOROUGH OF SOUTH PLAINFIELD, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY AMENDING CHAPTER 187, "VEHICLES AND TRAFFIC" OF THE CODE OF THE BOROUGH OF SOUTH PLAINFIELD

BE IT ORDAINED by the Mayor and Council of the Borough of South Plainfield, County of Middlesex, State of New Jersey that Chapter 187, Vehicles and Traffic, of the Code of the Borough of South Plainfield shall be amended as follows:

ADD to Section 187-37 "Enforcement of Traffic Regulations on Private Property" the following:

- G. Colonial Oaks Complex. The Borough of South Plainfield Police Department shall enforce specific regulations for the private property of the Colonial Oaks Complex development in accordance with the following.
 - (1) General Parking.
 - (a) All vehicles must park in designated areas and between the lines provided.
 - (b) Handicapped Parking. All stalls shall be eight (8') feet wide for standard cars and signed with the R7-8 and R7-8P (reserved parking sign and penalty plate), or eleven (11') feet wide for van accessible stalls and signed with the R7-8 (reserved parking sign), R7-8P (van sign), and R7-8Pen (penalty sign) in the designated parking areas for persons who have been issued handicapped parking permits by the Division of Motor Vehicles.
 - (2) Through Streets.
 - (a) The following streets or parts of streets are hereby designated as through streets. Stop signs shall be installed on the near right side of each street intersecting the through street except where yield signs are provided for in this designation.
