### PLEASE OBSERVE THESE INSTRUCTIONS FOR FILING LOCAL LAWS WITH THE SECRETARY OF STATE

1. Each local law shall be filed with the Secretary of State within 20 days after its final adoption or approval as required by section 27 of the Municipal Home Rule Law. The cited statute provides that a local law shall not become effective before it is filed in the office of the Secretary of State.

2. Each local law to be filed with the Secretary of State shall be an original certified copy.

3. Each local law shall be filed on a form provided by the Department of State. If additional pages are required, they must be the same size as the form. Typewritten copies of the text may be attached to the form. Only legible copies will be accepted.

4. File only the number, title and text of the local law.

5. In the case of a local law amending a previously enacted local law, the text must be that of the law as amended. Do <u>not</u> include any matter in brackets, with a line through it, italicized or underscored to indicate the changes made. The printed number of the bill and explanatory matter must be omitted.

6. For the purpose of filing a local law with the Department of State, number each local law consecutively, beginning with the number one for the first local law filed in each calendar year. The next number in sequence should be applied to each local law when it is submitted for filing, regardless of its date of introduction or adoption. The date of filing of a local law is the date on which the local law is placed on file by the Department.

It is suggested that municipalities use introductory identifying bill numbers for proposed local laws. After the local law is enacted (and approved by the voters, if required), the local law should then be numbered with the next consecutive local law number, as described above, and then submitted to the Department for filing.

7. Each copy of a local law filed with the Secretary of State shall have affixed to it a certification by the Clerk of the County legislative body or the City, Town or Village Clerk or other officer designated by the local legislative body. Certification forms are provided herewith.

## RESOLUTION ADOPTING A LOCAL LAW AMENDING CHAPTER 101 (TENNIS COURTS) TO ADD PICKLEBALL COURTS

WHEREAS, the Board of Trustees of the Village of Southampton is considering amending §101 (Tennis Courts) of the Village Code of Southampton by adding Pickleball Courts; and

WHEREAS, a public hearing was held by the Village Board on February 8, 2024 and March 14, 2024, at which time all persons either for or against said amendment were heard; and

WHEREAS, the Board of Trustees of the Village of Southampton has determined that this proposed local law is considered an "Unlisted Action" under 6 NYCRR Part 617.4 provisions of the New York State Environmental Quality Review Act (SEQRA); and

WHEREAS, the Southampton Village Planning Director, prepared a Short Environmental Assessment Form Parts I and a Full EAF Form Part 2 dated February 6, 2024 which identified no, or small impact may occur and a Full EAF Form Part 3 which determined there would be no significant adverse impacts on the environment;

NOW THEREFORE BE IT RESOLVED that the Village Board of Trustees hereby assumes Lead Agency status as there are no other involved agencies and issues a Negative Declaration pursuant to SEQRA as there are no significant negative environmental impacts anticipated by this zoning amendment; and be it further

RESOLVED, that Local Law No. 8 of 2024 is hereby adopted as follows:

## LOCAL LAW NO. 8 OF 2024

A LOCAL LAW amending Chapter 101 (Tennis Courts) of the Village Code of Southampton by adding Pickleball Courts.

**SECTION 1**. The Village Code of the Village of Southampton is hereby amended by adding the underlined words.

Chapter 101 Tennis and Pickleball Courts

§ 101-1 Permit required; display.

§ 101-2 Qualifications for permit.

§ 101-3 Permit fees; duration; issuance.

§ 101-4 Promulgation of rules and regulations.

§ 101-5 Penalties for offenses.

# § 101-1 Permit required; display.

No person shall play upon or use any tennis court, <u>pickleball</u> or paddle tennis court owned or maintained by the Village of Southampton unless each of the persons participating in a game of tennis, <u>pickleball</u>, paddle tennis or other purposes at a particular time thereon shall have a valid tennis/<u>pickleball</u> permit authorizing him to do so and, further, unless such permit is placed, by means of a chain or otherwise, at the main entrance of the court being used so as to be plainly visible to any person approaching the main entrance to such court.

## § 101-2 Qualifications for permit.

No person shall be entitled to such a tennis/pickleball permit unless he is a resident of the Village of Southampton.

§ 101-3 **Permit fees; duration; issuance.** Tennis/<u>pickleball</u> permits shall be issued by the Village Clerk or by such other person as the Board of Trustees shall from time to time designate, as follows:

<u>A.</u> To a qualified resident of the Village of Southampton, upon payment of a fee of \$10 for an individual, \$30 for a family;<sup>HI</sup> or such other amounts as the Board of Trustees may hereafter fix by resolution of said Board, which permit shall be valid for the calendar year during which it is issued. In connection with the issuance of a family permit, a separate permit shall be issued to each of the persons who shall comprise the immediate family of the resident making application and who reside with him within the Village of Southampton, and the name of each such person shall be listed on the application for a family permit.

# § 101-4 Promulgation of rules and regulations.

The Board of Trustees shall, by resolution, adopt rules and regulations pertaining to the use of such courts. The violation of any of such rules and regulations shall constitute a violation of this chapter.

# § 101-5 Penalties for offenses.

Any person who violates this chapter or fails to comply with any of its requirements shall, upon conviction thereof, be subject to the penalties provided in Article II of Chapter 1 of the Code of the Village of Southampton.

## Section 2. Amendment

The proposed Local Law is enacted pursuant to NYS Village Law 7-700, as well as Municipal Home Rule Law \$10(1)(ii)(a)(11) and (12).

## Section 3. Severability

If any clause, sentence, paragraph or part of this Local Law, or the application thereof to any person, firm or corporation, or circumstance shall be judged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect or impair or invalidate the remainer thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision or part of this Local Law, or in its application to the person, individual, firm, or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

## Section 4. Effective Date

This Local Law shall take effect immediately upon filing with the Secretary of State pursuant to Municipal Home Rule.
