Section 138-44(B)(3)(a)[5] of the Zoning Code of the Town of Southeast is amended to read as follows:

[5] If the subject property lies adjacent to, or in the event the relative proximity of a cooperative housing corporation to the subject property requires the giving of notice of an application to owners within the cooperative housing corporation, notice shall be deemed sufficient if given to the board of directors of the cooperative housing corporation in the manner prescribed herein. If the subject property lies within a cooperative housing corporation, notice shall be deemed sufficient if given to [i] the owners of record of the immediately adjacent tax lots (where artificial tax lot splits exist) or to leaseholders immediately adjacent to the subject property within the cooperative housing corporation and [ii] to the board of directors of such cooperative housing corporation.
