Chapter 103 of the Town Code (Peddling and Soliciting); Paragraphs "C", "D" and "F" of Section 103-8 (Permits; Fee) are amended to read as follows:

C. Permits shall be issued annually, dates of which shall be determined by the applicant. Applications for such permits shall be available to residents or established businesses located within the Town of Southeast from November 1 through November 30 of each year for the following year.

D. The annual fee for a food truck permit shall be set by the Town Board and included in the annual fee schedule adopted by the Town Board, as the same may be amended from time to time. Any permit issued to a veteran shall be exempt from the payment of the annual fee. To be exempt from the payment of the requisite permit fee, such veteran shall actually be engaged in the operation of the food truck and shall be present at the location at all times the food truck is in operation.

F. Secondary permits shall be made available to existing food truck permit holders who wish to provide food vending services on municipally owned properties on a monthly, weekly or daily basis. The fee for such secondary permit shall be set forth in the annual fee schedule, as the same may be amended from time to time.
