

**TOWNSHIP OF SOUTH HANOVER
ORDINANCE 6-2023**

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE TOWNSHIP OF SOUTH HANOVER, DAUPHIN COUNTY PENNSYLVANIA, CHAPTER 15 (MOTOR VEHICLES), ARTICLE II (TRAFFIC REGULATIONS), SECTION 201 (MAXIMUM SPEED LIMITS ESTABLISHED ON CERTAIN STREETS) BY ADDING TO THE LIST OF STREETS ON WHICH THERE IS A MAXIMUM SPEED LIMIT AND TO AUTHORIZE THE INSTALLATION AND ENFORCEMENT OF STREET REGULATORY SIGNAGE.

WHEREAS, pursuant to the Pennsylvania Vehicle Code, 75 Pa. C. S. Sections 3362(a) and (b), 3363, and 6109(a)(10) and (11) (e), a local municipal corporation is authorized to establish maximum speed limits and to post appropriate signage regulating speed limits;

WHEREAS, the Township of South Hanover has undertaken to conduct Traffic Engineering Speed and Sign Studies of certain streets within the Township to determine the safe running speeds on these streets and to designate locations for installation of appropriate signage regulating maximum speed limits on these streets;

WHEREAS, the regulatory studies recommended the maximum speed limit of 30 MPH for the entire length of Short Drive (T-491), East Bound & West Bound (EB & WB,) and the placement of appropriate regulatory signage; and,

WHEREAS, the enactment of this Ordinance and the imposition of speed limits is necessary for the protection and preservation of the health, safety, and welfare of the residents of the Township.

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of South Hanover, Dauphin County, Pennsylvania, and it is hereby enacted and ordained as follows:

SECTION 1. The Code of Ordinances of the Township of South Hanover, Chapter 15 (Motor Vehicles), Article II (Traffic Regulations), Section 201 (Maximum speed limits established on certain streets), is hereby amended to add to the list of Streets on which maximum speed limits have been established the following:

Street	Between	Maximum Speed Limit
Short Drive (EB & WB) (T491)	N Hoernerstown Road (SR2003) and Red Top Road (SR2024)	30 MPH

SECTION 2. The Township of South Hanover Board of Supervisors shall cause these streets to be posted with appropriate signage advising of the speed limits imposed by this Ordinance.

SECTION 3. This Ordinance shall be enforced by the Pennsylvania State Police and/or any other authorized law enforcement agency in accordance with the provisions of the Vehicle Code of Pennsylvania as it pertains to fines and other penalties.

SECTION 4. SEVERABILITY. The provisions of this Ordinance shall be severable, and if any of the provisions thereof shall be found to be invalid or unenforceable, the remaining provisions of this Ordinance shall remain in effect.


SECTION 5. REPEALER. All ordinances or parts of ordinances or resolutions conflicting or inconsistent with any of the provisions of this Ordinance are hereby repealed but only insofar as same are in direct conflict or directly inconsistent with this Ordinance.


SECTION 6. EFFECTIVE DATE. This Ordinance shall take effect five (5) days after the date of its enactment.


