A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF SOUTH HANOVER, DAUPHIN COUNTY, PENNSYLVANIA, AUTHORIZING THE SUBMISSION OF A FEDERAL FUNDING GRANT APPLICATION FOR THE DAUPHIN COUNTY 2024 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM IN THE AMOUNT OF TWO HUNDRED AND FIFTY THOUSAND (\$250,000.00) DOLLARS FOR THE INSTALLATION OF NEW PUBLIC SANITARY SEWERS WITHIN THE CRESTVIEW MANOR, PLEASANT VIEW, AND SAND BEACH RESIDENTIAL DEVELOPMENTS OF THE TOWNSHIP.


BE IT RESOLVED that the Board of Supervisors of the Township of South Hanover, Dauphin County, PA (Applicant) hereby authorizes the submission of a Federal Funding Grant Application for the Dauphin County 2024 Community Development Block Grant (CDBG) Program in the amount of Two Hundred and Fifty Thousand Dollars (\$250,000.00). The Grant Application is for the installation of new public sanitary sewers within the Crestview Manor, Pleasant View and Sand Beach residential developments of the Township.


BE IT FURTHER RESOLVED that the Applicant does hereby designate Stephen Cordaro, Chairperson of the Board of Supervisors, as the official to execute all documents and agreements between South Hanover Township and Dauphin County to facilitate and assist in obtaining the requested grant and any grant award documents and agreements.


