ORDINANCE OF THE TOWNSHIP OF SOUTHAMPTON, COUNTY OF BURLINGTON, NEW JERSEY, THE APPROPRIATION OF \$50,000 FOR MAINTENANCE TO SEWER SYSTEM WITHIN THE SEWER UTILITY FUND AND APPROPRIATION OF \$50,000 FROM THE RESERVE FOR MAINTENANCE TO THE SEWER PLANT ACCOUNT

WHEREAS, any capital ordinance approved for the sewer utility is required to be a completely separate ordinance from any general capital ordinance; and

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Township Committee of the Township of Southampton, County of Burlington, New Jersey, the appropriation of \$50,000 for Maintenance to Sewer System within the Sewer Utility Fund Appropriation of \$50,000 from the reserve for Maintenance to the Sewer Plant Account as recommended by the Auditor; and this ordinance transfers available capital funds to permit award of the projects; and


