ORDINANCE NO. 2023-10

BOROUGH OF SOUTH TOMS RIVER

AN ORDINANCE PROVIDING FUNDING FOR THE PURCHASE OF A COMPACT WHEEL LOADER FOR THE BOROUGH OF SOUTH TOMS RIVER AND APPROPRIATING \$70,000 FOR SUCH PURPOSE.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SOUTH TOMS RIVER, IN THE COUNTY OF OCEAN AND STATE OF NEW JERSEY, AS FOLLOWS:

- <u>Section 1</u>. The Borough of South Toms River, in the County of Ocean, New Jersey, authorizes funds for the purchase of a Compact Wheel Loader for the Borough of South Toms River to be funded from the sources specified in Section 2 of the Ordinance.
- Section 2. The amount of \$70,000 is hereby appropriated for the purposes stated in Section 1 of the Ordinance and which amount was funded from the General Capital Fund Balance in the amount of \$70,000.
- Section 3. In connection with the purpose and the amount authorized in Sections 1 and 2 hereof, the Borough determines the purpose described in Section 1 hereof is not a Current Expense and is an improvement which the Borough of South Toms River may lawfully make as a general improvement.
- Section 4. All ordinances or parts of ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.
- Section 5. This Ordinance shall take effect immediately upon due passage and publication according to law.
