

**BOROUGH OF SPRINGDALE**

**ORDINANCE NO. 1292**

**AN ORDINANCE OF THE BOROUGH OF SPRINGDALE, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, AMENDING ORDINANCE 1249, AS CODIFIED IN THE CODIFIED ORDINANCES OF THE BOROUGH OF SPRINGDALE AT ARTICLE VI SECTION 460-41 ET.AL. WHICH ESTABLISHED STANDARDS FOR APPLICATION, GRANTING, RENEWAL AND REVOCATION OF HANDICAPPED PAKING SPACES ON PUBLIC ROADWAYS WITHIN THE BOROUGH, AND INCLUDING THE ESTABLISHMENT OF CERTAIN FEES FOR SAME.**

**WHEREAS**, the Borough of Springdale has the authority to regulate parking on public roadways within the Borough of Springdale;

**WHEREAS**, in furtherance of that authority, Borough Council enacted Ordinance No. 1249 which establishes the standards for application, granting, renewal and revocation of handicapped parking spaces on public roadways within the Borough;

**WHEREAS**, Borough Council desires to revise and amend said Ordinance regarding Application requirements and to establish fees associated with same.

**THEREFORE, BE IT ORDAINED AND ENACTED**, by the corporate authorities of the Borough of Springdale, Allegheny County, Pennsylvania, and it is hereby enacted by the authority of the same as follows:

**SECTION I. REVISIONS TO ORDINANCE 1249**

**Section 2.2 of Ordinance 1249 (Section 460-42(B) of the Codified Ordinances) regarding Application renewals is hereby revised as follows:**

**Section 2.2.** Applications for renewal shall be submitted to the Borough office yearly following receipt of a notice for renewal letter, within the designated time period set forth in Application for Renewal.

**SECTION II. AMENDMENTS TO ORDINANCE 1249**

**A new Section 1.8 of Ordinance 1249 (Section 460-41(H) of the Codified Ordinances) is hereby added to the "Application Process" as follows;**

**Section 1.8.** The Borough may from time to time establish fees associated with the handicapped parking application process which may include, but are not limited to Original Application Fees, Application Renewal Fees and Change of Address Fees. All such fees shall be set forth on the Application and no Application will be processed or handicapped parking approved until such time said fees are paid.

**A new Section 3.7 (Section 460-43 (G) of the Codified Ordinances) regarding "Location of handicapped parking spaces" is hereby added as follows:**

**Section 3.7.** No handicapped parking space shall be issued for parking on Pittsburgh Street and Colfax Street or any other Street as determined by the Springdale Borough Police, in their sole discretion, to create a safety hazard for the granting of same. Any street where handicapped parking is prohibited shall be set forth on the Handicapped Parking Application.

**SECTION III. SEVERABILITY**

The provisions of this Ordinance shall be severable and if any of its provisions or other parts shall be held to be unconstitutional, illegal, unenforceable or otherwise invalid, such shall not affect the validity and enforceability of the remaining provisions and other parts of this Ordinance. Borough Council hereby declares its legislative intent to be that this Ordinance would have been adopted had such unconstitutional, illegal, unenforceable or otherwise invalid provisions or parts not been included herein.

**SECTION IV. SAVINGS CLAUSE**

The provisions of this Ordinance, so far as they are the same as Ordinances 294, 336 and 514, or any other Ordinance or regulation in force prior to the enactment of this Ordinance, are intended as a continuation of those existing Ordinances and regulations and not as new enactments. The provisions of this Ordinance shall not affect any act done or liability incurred, nor shall they affect any suit or prosecution pending or to be instituted to enforce any existing or repealed Ordinance, regulation or parts thereof.

**SECTION V. INCONSISTENT ORDINANCES REPEALED.**


All Ordinances or parts of Ordinances of the Borough of Springdale are hereby repealed only to the extent the same are irreconcilably inconsistent herewith.

**SECTION VI. EFFECTIVE DATE.**


This Ordinance shall take effect immediately.


