Be it enacted by the Town of Spencer, County of Tioga as follows:

Section 1. Legislative Intent

It is the intent of this local law to opt out of allowing cannabis retail dispensaries and on-site cannabis consumption sites in the Town of Spencer that would otherwise be allowed under Cannabis Law Article 4.

Section 2. Authority

This local law is adopted pursuant to Cannabis Law § 131 which expressly authorizes the town board to adopt a local law requesting the Cannabis Control Board to prohibit the establishment of cannabis retail dispensary licenses and/or on-site consumption licenses within the jurisdiction of the town and is subject to a pemissive referendum, the procedure of which is governed by Municipal Home Rule Law § 24.

Section 5. Permissive Referendum/Referendum on Petition

This local law is subject to a referendum on petition in accordance with Cannabis. Law § 131 and the procedure outlined in Municipal Home Rule Law § 24.

Section 6. Effective date
This local law shall take effect immediately upon filing with the Secretary of State.
