# <u>AMEND LOCAL LAW NO. §239-41 – SCHEDULE OF RATES FOR TAXICABS</u>

## <u>§ 239-41 Schedule of rates for taxicabs.</u>

No taxicab fare or charges shall exceed the following: \$4.50 \$6.00 for the first two passengers and an additional \$.25 for each additional passenger over eight years old, being conveyed from any location within the Village to any other location within the Village. An unaccompanied child, regardless of age, may be charged the full adult fare. A child under the age of eight shall not be charged when accompanied by an adult. When there is over one inch of snow on the roads, the first two passengers rate increases to \$8.50.
