- 1. <u>Amend Chapter 239-4 ("Taxicab or vehicle for hire operating license required") to add new section 239-4(a):</u>
- § 239-4(a) Any person who drives a vehicle in Spring Valley that is marked "Taxi" whether such vehicle is being driven for the purpose of either retrieving or returning passengers, shall be presumed to be operating a taxicab within the Village of Spring Valley. If such driver is not a licensed taxicab driver pursuant to §239 of the Village of Spring Valley Code, said driver shall be subject to penalties not exceeding \$5,000.00 and/or 15 days in jail, and the subject vehicle may be impounded for a period not to exceed thirty (30) days.
  - 2. <u>Amend Chapter 239-13 heading ("Inspection and reinspection of vehicles; inspection stickers.") to read as follows:</u>

## § 239-13 Vehicle inspection and maintenance; Modification of Rules and Regulations

- 3. Amend Chapter 239-13 to add new section 239-13.C.1 as follows:
- § 239-C.1. Any driver who drives a vehicle which is held out to be a taxicab must ensure that such vehicle meets minimum standards including licensing, insurance and inspection. Failure to comply with this requirement shall subject the driver to penalties and shall further subject the vehicle to impoundment.
  - 4. <u>Amend Chapter 239-15 ("Display of driver's photograph rate card and rates.") to add new section 239-15.1 as follows:</u>
- §239-15.1: Any taxicab driver who is driving off duty must exhibit an "Off Duty" sign on the exterior of the vehicle. Said "Off Duty" sign must be clearly visible during daytime as well as during evening hours.
  - 5. <u>Amend Chapter 239-30 ("Transfer or assignment of taxicab operating license prohibited")</u> to add new sections 239-30.1, 239-30.2, 239-30.3 and 239-30.4 as follows:
- § 239-30.1: If a taxicab dispatcher shall dispatch to a driver or drivers who have not received a Village of Spring Valley taxi license, such dispatcher shall be subject to penalties not exceeding \$5,000.00 and/or 15 days in jail.
- §239-30.2: If a taxicab dispatcher is convicted of dispatching to a driver or drivers who have not received a Village of Spring Valley taxi license more than two times, such dispatcher shall be subject to penalties not exceeding \$5,000.00 and/or 15 days in jail, as well as revocation of their license to operate and/or dispatch within the Village of Spring Valley.
- §239-30.3: Any taxicab driver who gives his or her dispatch connection system to an unlicensed driver with the intent of permitting the unlicensed driver to use such connection for the purpose of receiving a dispatch or dispatches, shall be subject to penalties not exceeding \$5,000.00 and/or 15 days in jail, as shall be further subject to revocation of his or her license to operate and/or dispatch within the Village of Spring Valley.
- §239-30.4: If a taxicab operator, licensed by the Village of Spring Valley shall authorize or permit an unlicensed operator to drive a car that says "taxi" or does not say "off duty" then

the licensed operator shall be subject to penalties not exceeding \$5,000.00 and/or 15 days in jail, and the subject vehicle may be impounded for a period not to exceed thirty (30) days.

6. Amend Chapter 239-38 ("Trip records") to add new section 239-38.1 as follows:

§239-38.1: Any taxicab dispatcher or dispatch company that dispatches to taxicabs for the purpose of retrieving passengers within the Village of Spring Valley, shall be required to provide a monthly roster to the Clerk of the Village of Spring Valley by the 25<sup>th</sup> day of each month. Such roster shall clearly indicate the date, time and name of the intended driver for every retrieval dispatched during the previous month. Failure to provide such roster in a timely fashion and as stated above shall subject such dispatcher to penalties pursuant to §239 of the Village of Spring Valley Code.
